C-825 Presentation of Unaudited Accounts

- (a) March 2014 – Year End Summary

Income = The year ended with a surplus of **£1268** to budget

Expenditure = The year ended with a surplus of **£17779** to budget

Reserves = Fell from £79200 by **£8842** to **£70358**

April 2014 All figures versus Budget The unaudited figures, verified by our Internal Auditor, indicate: -

Income = **£716** more than budget (including a Government Grant of £390)

Expenditure = **£1678** less than budget

- (c) Audit – Accounts 2013 - 14
